














Q8 In your role, how often do you meet or engage with community groups or entities?




Q9 With whom, do you engage normally?



protection programs, what is level of engagement with children?


Q11 In your community-based child protection programs, what is level of engagement with adults?




Q12 Have community-based child protection groups been trained on referral pathways?




Q13 Are community-based child protection groups been actively involved in identifying and referring to formal service providers?




Q14 Do community groups work in collaboration with formal service providers?














Q22 Are there common, inter-agency or

agency specific standards in place for community-based child protection programs?




Q23 If yes, common agency-specific standards for what types of programs?
